

**SD State Board of Dentistry
Regular Meeting
Delta Dental Shared Conference Room
Friday October 22, 2010 10:00 a.m.**

President Sachau called the meeting to order at 12:35 pm CST.

Second by Johnson. Motion carried.

Motion to approve the Agreed Disposition and Waiver of Hearing in case number 4.0809 and 13.0910 against Dr. John Wightman, DDS by Wilson. Second by Johnson. Motion carried.

There being no other business, there was a motion to adjourn by Wilson. Second by Ticknor. Motion carried. The meeting was adjourned at 4:50pm.
