

**SD State Board of Dentistry
Regular Meeting
Delta Dental Shared Conference Room
Friday January 7, 2011 10:00 a.m.**

President Sachau called the meeting to order at 10:15 a.m.

Present: Dr. Randy Sachau, Dr. Roger Wilson, Audrey Ticknor, Dr. Robin Hattervig, Dr. Roy Seaverson, Dr. Geoffrey Johnson, Tina Van Camp, Brittany Novotny and Stevi Herrman. Guests included Paul Knecht, Jeanette Miranda, Marti Pollard, Stacey Bahre, and Keri Thompson.

The Board interviewed Dr. Tony LeRoy Peterson for licensure by credential verification.

Motion to approve corporate applications of Munsinger Dental P.C., Murray M. Thompson, D.D.S., P.C., Bechtold Thompson Dental Clinic, Prof. LLC and Manke Family Dentistry, P.C. by Seaverson. Second by Johnson. Motion carried.

Motion to approve the minutes of October 22, 2010 as amended by Wilson. Second by Van Camp. Motion carried.

Novotny presented the financial statements. Motion to approve the financial statements by Hattervig. Second by Seaverson. Motion carried.

Novotny gave an office update.

Paul Knecht, Executive Director of the South Dakota Dental Association, presented draft legislation regarding Public Health Supervision/Collaborative Supervision. Discussion ensued.

Bill Sorace presented information on the St. Francis Mission Dental Clinic, a non-profit Dental Clinic that is looking to provide dental services at St. Francis, SD, located on the Rosebud Indian Reservation. Discussion ensued.

Motion to have President Sachau appoint a task force of 3-5 members, including Board members, one dental hygienist and one dentist, to work on updates and revisions to the Dental Practice Act and associated rules governing the dental profession by Johnson. Second by Wilson. Motion carried.

President Sachau appointed Dr. Roger Wilson, Dr. Jay Crossland, Dr. Denis Miller, Dr. Brent Henriksen, Dr. Ed Kusek, and Dr. Chris Harris to the Anesthesia Credentialing Committee. President Sachau appointed Dr. Roger Wilson as the Chair of the committee.

Motion to approve the Dental Anesthesia Assistant National Certification Examination (DAANCE) as a course that satisfies *ARSD 20:43:09:10: Permit requirements for monitoring patients under general anesthesia and deep sedation or moderate sedation* for one year by Wilson. Second by Johnson. Motion carried.

Motion to approve "IV Conscious Sedation" at the Medical College of Georgia School of Dentistry in Augusta, GA; "Medical Emergencies, Local Anesthesia and Moderate Sedation in Dental Practice" at Miami Valley Hospital in Dayton Ohio; "Conscious Patient Management with IV and Nitrous Sedation in General Dentistry" at Montefiore Medical Center in The Bronx NY; "Mini-Residency: An Intensive Course in Conscious Sedation" at the University of Alabama in Birmingham, AL; "Learn IV Sedation" at the Oregon Academy of General Dentistry in Portland, OR; "Clinical Intravenous Sedation" at The Herman Ostrow School of Dentistry of USC in Los Angeles, CA; "Conscious Sedation Training Program" at the University of Minnesota School of Dentistry in Minneapolis, MN; and "Moderate (Conscious) Sedation for the Dental Practitioner" at the University of Illinois in Chicago, IL as courses that satisfy ARSD 20:43:09:04: *Moderate sedation permit requirements* for one year by Wilson. Second by Seaverson. Motion carried.

The Board interviewed additional candidates for licensure by credential verification. Dentist credential applicants were: Dr. Richard John Dohrmann and Dr. Timothy Joseph Holton.

Motion to approve credential dentist applications of Dr. Richard John Dohrmann, Dr. Tony LeRoy Peterson and Dr. Timothy Joseph Holton by Johnson. Second by Ticknor. Motion carried.

Motion to approve regular dentist applications of Dr. Robin Sueku Yamaguma, Dr. Samuel Warren Cowgill, Dr. Kevin James Connor, Dr. Tennille Harmonie Penn and Dr. Clinton Edward Norby by Hattervig. Second by Seaverson. Motion carried.

Motion to approve dental hygienist reinstatement application of Tracey Marie Volk and regular dental hygienist application of Michelle Joyce Sasse by Seaverson. Second by Hattervig. Motion carried.


