President Randy Sachau called the meeting to order at 6:35 pm Central.

Present were: Dr. G. Randy Sachau, Dr. Roy Seaverson, Dr. Robin Hattervig, Dr. Roger Wilson, Audrey Ticknor and Brittany Novotny.

The Board undertook a discussion on the proposed rule revisions and fee increases.

Motion to waive the temporary license fee for new graduates when the increased temporary license fee is implemented by Wilson. Second by Hattervig. Motion carried.

Motion to proceed with rulemaking process to increase the temporary license fee for Dentists and Dental Hygienists to \$50 by Wilson. Second by Seaverson. Motion carried.

Motion to proceed with rulemaking process to increase the Application for Dental License by Credential Verification to \$500 and the Application for Dental Hygienist License by Credential Verification to \$200 by Wilson. Second by Hattervig. Motion carried.

Motion by Wilson to proceed with rulemaking process to adjust fees charged by Board to the following:

Renewals: Dentist \$150, Dentist Nitrous Oxide \$40, Dentist Moderate Sedation \$50, Dentist General Anesthesia and Deep Sedation \$50, Dental Hygienist \$75, Dental Hygienist Nitrous Oxide \$20, Dental Hygienist Local Anesthesia \$20, Advanced Dental Assistant \$20, Advanced Dental Assistant Nitrous Oxide \$20, Radiographer \$20, Continuing Education (Dentist and Dental Hygienist) \$20, Corporation \$25.

Licensure: Dentist \$150, Dentist - Credential Verification \$500, Dental Hygienist \$150, Dental Hygienist – Credential Verification \$200.

Permits: Dentist Nitrous Oxide \$40, Dentist Moderate Sedation \$50, Dentist General Anesthesia and Deep Sedation \$50, Dental Hygienist Nitrous Oxide \$40, Dental Hygienist Local Anesthesia \$40.

Registrations: Advanced Dental Assistant \$40, Radiographer \$40, Advanced Dental Assistant Nitrous Oxide \$40, Corporation \$100.

Temporary Registrations: Dentist \$50, Dental Hygienist \$50.

Examinations: Dentist - Jurisprudence Examination \$225, Dental Hygienist - Jurisprudence Examination \$115.


Reinstatement: Dentist \$395, Dental Hygienist \$210, Advanced Dental Assistant \$60, Radiographer \$60.

Other: Replacement Certificates \$15.
