Motion to approve the minutes of October 12, 2012 by Ticknor. Second by Schaack. Motion carried.

Novotny presented the financial statements. Motion to approve the financial statements by Ticknor. Second by Seaverson. Motion carried.

Novotny presented an office update.

Motion to approve the Gift of Appreciation Declaratory Ruling by Determan. Second by Seaverson. Motion carried.

Motion to appoint Dr. Orin Ellwein as a board investigator and to approve the investigator contract for Dr. Orin Ellwein by Seaverson. Second by Determan. Motion carried.

Motion to approve the dentist credential verification applications of Dr. Christopher Diaz-Freed, Dr. Dawn Toft and Dr. Adam Holecek by Ticknor. Second by Determan. Motion carried.

Motion to approve the dental hygienist credential verification applications of Erika Moog and Cynthia Clements Foss by Ticknor. Second by Determan. Motion carried.

Novotny presented an update on the 2013 Legislative Session.

Motion to allow dental applicants to apply clinical practice hours completed during a residency program approved by the American Dental Association Commission on Dental Accreditation to the active practice requirement for licensure by credential verification by Determan. Second by Seaverson. Motion carried.

Motion to approve the American Heart Association Advanced Cardiac Life Support (ACLS) course as an equivalent program to the American Heart Association for the Healthcare Provider and the American Red Cross for the Professional Rescuer courses by Seaverson. Second by Schaack. Motion carried.

Motion by Seaverson to approve as anesthesia related continuing education, 4 hours per ACLS certification with an 8 hour maximum in a 5 year continuing education cycle. Second by Ticknor. Motion carried.

Motion to deny the request for continuing education credit for Dental Assisting National Board, Inc. (DANB) testing by Seaverson. Second by Ticknor. Motion carried.

Motion to appoint Dr. Hattervig as the South Dakota Central Regional Dental Testing Service (CRDTS) steering committee member for the meeting to be held August 23-24, 2013 by Determan. Second by Ticknor. Motion carried.

The Board received a request for clarification regarding specialties and who can advertise as a specialist pursuant to ARSD 20:43:04:01. Motion by Determan to respond that advertising a specialty is limited to the specialties listed in ARSD 20:43:04:01. Second by Ticknor. Motion carried.

The Board received a policy statement from the American Academy of Sleep Medicine.

Motion to approve the Safe and Effective Management of the Apprehensive Patient, Medical Urgencies and Emergencies in Dental Practice and Pharmacotherapeutic Considerations for Dental Practice provided by Dr. Daniel Becker on January 09-10, 2013 as a course that satisfies *ARSD 20:43:09:10: Permit requirements for monitoring patients under general anesthesia and deep sedation or moderate sedation* by Ticknor. Second by Seaverson. Motion carried.

Motion to adjourn by Ticknor. Second by Seaverson. Motion carried. The meeting was adjourned at 11:40.
