Dr. Nathaniel Tippit and Kelly Reich, RDH, made a presentation to the Board on behalf of WREB.

The Board discussed the requirements to satisfy continued competency per ARSD 20:43:09:08 as it relates to licensees that hold a Moderate Sedation Permit or General Anesthesia and Deep Sedation Permit. Public input was received. Motion to draft an advisory opinion that includes guidelines regarding continued competency in ARSD 20:43:09:08 that includes 25 cases annually for Moderate Sedation permit holders and 50 cases annually for General Anesthesia and Deep Sedation permit holders by Wilson. Second by Hornstra. Motion carried.

Amanda McKnelly, MS, LAC and Maria Eining, MA, LPC-MH, LAC, QMHP made a presentation to the Board on behalf of the Health Professionals Assistance Program (HPAP). The Board discussed offenses that would warrant referral into the HPAP.

Mr. Walter Raby presented the Black Hills Dental Education Dental Assistant Training Proposal and requested approval of this program per ARSD 20:43:08:05. Dr. Ann Bolman and Steve Buchholz from Western Dakota Tech (WDT) provided an update on the current status of the Dental Assisting Program at WDT.

Motion to deny the request for approval of the Black Hills Dental Education Dental Assistant Training Proposal presented by Mr. Walter Raby by Van Camp. Second by Wilson. Motion carried.

Dr. Vince Jones provided an update on the evaluation of the regional examinations.

Motion to appoint Dr. Vince Jones to the CRDTS exam review committee for one year by Van Camp. Second by Wilson. Motion carried.

Motion to appoint Dr. Robin Hattervig to serve as the individual that approves continuing education requests by Schaack. Second by Wilson. Motion carried.

Motion to appoint Dr. Jesse Fast to the Anesthesia Credentials Committee by Schaack. Second by Hornstra. Motion carried.

Novotny presented proposed changes to SDCL 47-12. Public input was taken.

Motion to amend section 10 to include action pending before any other state dental board and section 14 to include a July 1 renewal deadline by Wilson. Second by Hornstra. Motion carried.

The South Dakota Dental Association (SDDA) noted its support for the draft legislation as amended.

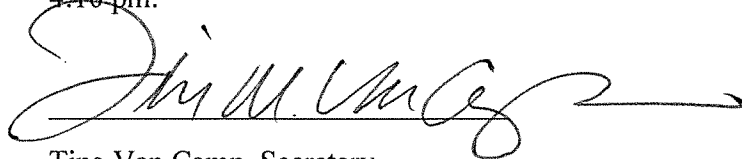
Motion to move forward with the proposed legislation as amended by Wilson. Second by Schaack. Motion carried.
