The Board and general counsel reviewed the draft specialty advertising administrative rules and stakeholder feedback that was received. Motion to release a second draft of specialty advertising administrative rules that incorporates a two-year full time residency requirement and to solicit stakeholder feedback by Renemans. Second by Van Dam. Motion carried. The Board noted the second draft of the administrative rules and an opportunity for stakeholders to provide feedback will be available on the Board's website in advance of the October board meeting.

Paul Knecht with the SDDA presented on the Wellbeing Program. Motion to approve a contract with the SDDA for \$9,000 to continue to provide funding for the Wellbeing Program for dental professionals statewide by Renemans. Second by Van Dam. Motion carried.

Motion to approve any CPR course that is a Basic Life Support course intended for a Healthcare Provider; includes knowledge and objectives in accordance with the American Heart Association Guidelines for BLS or American Heart Association Guidelines for CPR and ECC; and includes a hands-on skill assessment by Schaack. Second by Van Dam. Motion carried.

Motion to approve the Board Policies, as presented, by Renemans. Second by Van Dam. Motion carried.

The Board noted the updated CPR course information will be included in the Continuing Education Guidelines. Motion to approve the Continuing Education Guidelines, as amended, by Renemans. Second by Schaack. Motion carried.

Second by Hornstra. Motion carried. The Board took a moment to thank Dr. Doerr for his outstanding leadership and commitment during his term as President.

Motion to appoint Dr. Brian Prouty as the ACC Chair by Van Dam. Second by Renemans. Motion carried. The Board took a moment to thank Dr. Van Dam for his strong leadership during his term as Chair of the ACC.

Motion to approve annual memberships in the American Association of Dental Boards (AADB) and the American Association of Dental Administrators (AADA) by Renemans. Second by Hornstra. Motion carried.

Motion to approval travel for two representatives to attend the AADB meetings and one representative to attend the AADA meetings by Renemans. Second by Schaack. Motion carried.

Motion to adjourn by Renemans. Second by Schaack. Motion carried.
